Georgia Farm Bureau Announces The 2010 Art Contest

ATTENTION ALL GEORGIA HIGH SCHOOL STUDENTS!

Georgia Farm Bureau, your county Farm Bureau and SunTrust Bank, Middle Georgia have an opportunity for you to apply your artistic skills to their annual art contest. Here are the contest rules and prizes:

CONTEST GUIDELINES

- The contest is open to students in Georgia, grades 9 through 12, for the 2009-2010 academic year.
- The finished artwork must be on 8¹/₂x11-inch white paper. It should be either in black ink or dark pencil (soft lead). The artwork should be camera-ready.
- The student must be willing to allow Farm Bureau and SunTrust Bank to reprint copies of their drawings. The winning artwork becomes the property of Georgia Farm Bureau.
- All information on the entry form must be completed, including the signature of the parent or guardian.
- Entries should be submitted to the county Farm Bureau office. Each county will select one winner at the county level and submit it to the district level by the deadline date of **Friday, February 26, 2010**.
- Drawings will be judged on the following:
 - ☞ How well the artwork represents modern agriculture found in the student's county **OR** Georgia's agriculture industry.
 - ☞ Artistic merit.
- Previous state winners are not eligible.
